#### Letter from the President

The Council held a productive meeting in Paris last month. Several important decisions were taken about ways of strengthening our Society and improving the services that it offers to members.

The most exciting decision was to select the general theme of "Religion and Generations" for our next conference, to be held in Turin, Italy between 21st and 25th July 2003. This is a broad theme that will lend itself well to the varied interests of sociologists of religion. The organisation of the Opening Ceremony, the Inaugural Session and the two Plenary Sessions will be the responsibility of a Programme Committee consisting of Régine Azria, Jim Beckford (chairperson), Karel Dobbelaere and Franco Garelli.

Thanks to the hard work of Franco Garelli and his Italian Local Committee, steps are already being taken to provide high quality facilities for participants. There will also be an attractive programme of pre-conference and post-conference tours as well as a mid-week tour of sites of special religious interest around Turin. It is a beautiful city with impressive museums, elegant architecture, excellent restaurants and easy access to the Alps and to the other wonderful regions of Northern Italy. Accommodation will be available in a wide range of prices.

Now is the time to begin preparing your visit to Turin. You will find all the information you need about the procedures and deadlines for proposing sessions and papers later in this issue of Network. Further information will be posted on the ISSR/SISR website as it becomes available. Let me remind you that you can offer to organise a session on the conference theme or a session on an unrelated topic; you can offer to present a paper in these sessions or, alternatively, you can suggest an author-meets-critics session (only for books published since the last ISSR/SISR conference in August 2001). In addition, there will be sessions designed specially for New Researchers, meetings of Linguistic Groups, and sessions for Affinity Groups that might choose to dispense with formally presented papers. Please contact the General Secretary if you have any questions about the intellectual structure of the conference.

From now on, our website is going to serve as the main channel of communication between the ISSR/SISR and its members. Jim Spickard has completely revised the site, so please make a visit to: http://www.sisr.org without delay. If you have already 'bookmarked' this site, please re-type the address and re-set the bookmark. Otherwise, you may encounter some difficulties in reaching the updated site. Many thanks to Liliane Voyé for checking the French pages of the website.

Another electronic resource available to you is the e-mail user group for New Researchers. Véronique Altglas (EPHE, Paris) has set up New Researchers Network in conjunction with the ISSR/SISR in order to stimulate discussion, in French or English, about the sociology of religion among, for example, doctoral students, post-doctoral researchers and academics near the beginning of their career. More than 80 New Researchers have already joined the Network since it was set up last year. It is hoped that many of them will take part in the Turin conference and will begin preparing their sessions on-line in the near future.

#### Conference theme

#### RELIGION AND GENERATIONS

Does the concept of 'generation' have a changing significance in the sociology of religion? There has been an assumption that the passing of generations marked the transmission of religion as newer generations inherited religion primarily from older generations. But accelerating social and cultural change in the course of the twentieth century has disrupted these rhythms and has made family and historical generations a frequent source of rebellion and innovation.

The challenge for sociologists of religion is to consider how their research can take account of generational issues. In particular, they face questions about the need to rethink the very meaning of 'generation' and the responses of religions to the forces that precipitate the construction and self-construction of new generations. For example, to what extent can tension and conflict between generations be a creative force in religion?

These broad questions about religion and generations will be the focus of presentations in two plenary sessions. Three speakers and a discussant in each session will present both specific case materials and larger theoretical and methodological issues.

Speakers in the first plenary session will critically examine such generational effects on religion as the conflicts specific to some African countries, the impact of colonialism and post-colonialism on South Asian countries, and the ongoing mixing and clashing of cultures in Latin America.

Speakers in the second plenary session will pose questions like: How have different generations responded to the 'official' atheism of a previous period in Central and Eastern Europe? How have the different generations of the Muslim diasporas in Western Europe responded to their social, cultural and religious heritage? And how have different generations in Europe responded to the Christian heritage bequeathed by an earlier historical age?

Further elaboration of issues about religion and generations will take place in thematic sessions on topics such as:

Inter-generational religious transmission
Generational change in new religious movements
Atheism as the experience of a generation
Second generational religious experiences

#### FINANCIAL ASSISTANCE

The Council has set aside limited funds to assist participants in ISSR/SISR conferences coming from countries with non-convertible currencies. Those who wish to request financial assistance from the ISSR/SISR are asked to submit their applications to the General Secretary. Such support can only be offered if the following conditions are met in full:

- The applicant must agree to give a paper at the Conference and remain in residence for the duration of the conference.
- The quality of the proposed paper must be good. A paper that has already been published in French or English will not be accepted.
- The deadline for submitting applications for financial assistance is 31st October 2002. An Abstract of about 3 pages should accompany each application.
- The application must also contain a short curriculum vitae.
- The inability of the applicant to pay for participation in the Conference must be demonstrated.
- The application must be accompanied by a letter from the head of the applicant's academic department or research centre certifying that financial assistance cannot be obtained from the applicant's department, research centre or from national and international foundations.
- Applicants who are informed that their application has been approved in principle must submit the full text of their paper in English or French (between 5,000 and 6,000 words) to the General Secretary no later than 15th March, 2003.
- Successful applicants must become members of the ISSR/SISR and must submit their papers for consideration by the Editorial Committee for publication in <u>Social Compass</u>.
- Payment of financial assistance will be made only when the applicant sends the remaining part of the original ticket (not a photocopy) to the General Secretary after the conference.

Only those applicants who meet these conditions in full will be eligible for financial support from the ISSR/SISR. Applicants are also reminded that requests for funding cannot be met in full. Final decisions rest with the Programme Committee.

#### Vacant positions in the Council of the SISR/ISSR

#### **Call for canditates**

Elections will be organised early next year for the <u>positions of the following geographic regions</u> that become vacant, at the next conference:

France Japan Central and Eastern Europe

The following positions are <u>still vacant</u>:

Netherlands South Asia

According to Art. 20 of the statutes, the following rules should be followed to present candidates for your region:

- a) Vacancies shall be announced by the General Secretary in the bulletin of the Association at least six months before the elections. Candidates shall be members of the Association and shall be nominated in writing by two other members. The candidate shall signify his or her acceptance of nomination.
- b) The candidate and his or her sponsors shall belong to the geographic region for which the candidate is proposed.
- c) Nominations shall be submitted to the General Secretary who shall compile the list of candidates for election.
- d) Voting shall be by postal ballot and shall take place before the Conference which marks the end of the relevant period of office.

The terms of office of the following members of the council come to an end after having served for four years. According to art19 a) of the statutes they are re-eligible: "The members of the Council shall be elected for terms of four years. They shall be eligible for consecutive re-election once, excepting that those who are elected President, General Secretary or Treasurer shall be eligible for a total consecutive duration of membership of the Council of not more than three terms".

At its meeting in Paris in February 2002, the Council decided to recommend that the membership contribution of Full Members should be increased in line with changes in the cost of living since the membership fee was last changed more that eight years ago. Members will be invited to vote on this proposal.

At its meeting in Paris, the Council also decided to propose some changes in the Statutes. Members will be invited to vote on the proposed changes.

Who is going to be invited to vote for Council members, changes in subscription rates, and changes in the Statutes?

#### MEMBERS IN GOOD STANDING

According to art. 11 b of the present Statutes, membership shall be forfeited:

- a) by resignation in writing to the General Secretary;
- b) subsequent to non-payment of the annual dues at the end of the second year;

Consequently, ballots will be sent only to members in good standing: this means those who have paid their membership dues in 2001 and/or 2002

#### WE ARE SORRY TO HAVE TO INFORM YOU THAT:

in view of the enormous secretarial and postal costs involved in preparing and sending out our Newsletters and information to the membership, we will have to discard all postal addresses and e-mail addresses of colleagues who have not been in good standing at some time in the last four years.

We hope that this message will encourage all members and former members, who have not already done so, to contact us again by paying their membership dues. By doing so they will ensure that this is not the last time that they will receive a Newsletter from the General Secretariat.

If you think that this is a drastic measure, we want to inform you that the annual excess of expenditure over income is costing the SISR/ISSR about 5,000 to 6,000 euros, or \$4,300 to \$5,200, or  $\pounds$  3,000 to £3,6000

Unless we reduce these losses, it may become impossible for the SISR to offer financial assistance to colleagues from countries with non-convertible currency.
