This issue of Network contains important information about the upcoming conference of the ISSR, which will take place in Louvain-la-Neuve, Belgium from 2-5 July 2015. It also contains information about all the candidates running for election to the ISSR Council in preparation for the vote that will take place in April. All members will at that time receive links and instructions to cast their votes online during that month.

2015 marks the first year that the ISSR has expanded its funded activity to include more than the conference and the journal issue of Social Compass. During 2014, we set up a permanent Fund dedicated to funding a variety of activities. For 2015 we held a competition for helping to fund an international workshop. The winner of that competition is announced in this newsletter. We are also, for the first time in 2015 holding competitions for two prizes, the ISSR Best Article Award and the ISSR Student Paper Award (see the web site, on the homepage, for more information). The results for these awards will be announced at the conference.

For information on the conference itself, we invite you to visit the ISSR's web site, where we also encourage you to register for the conference and renew your membership, if applicable.

Vice- President

VÉRONIQUE ALTGLAS

Véronique Altglas has a PhD from the Ecole Pratique des Hautes Etudes in Paris. Following a postdoctoral fellowship at Warwick University and a Research Fellowship at Cambridge's department of sociology, she was appointed as a lecturer in sociology at Queen's University Belfast in 2009. Her research areas are globalisation of religion, transformations of religiosity in modern societies, and cross-national comparisons of the responses to religious diversity. She has conducted research on the transnational expansion of neo-Hindu movements and the management of minority religions in France and Britain. In more recent years, she has pursued a research interest in the popularisation of kabbalah in France, Britain, Brazil and Israel. This empirical research is inscribed in broader reflections regarding contemporary practices of bricolage, the making of identities, and epistemological issues within the sociology of religion.

Recent publications include: *Le nouvel hindouisme occidental*. Paris: Éditions du CNRS, 2005; *Religion and Globalization: Critical Concepts in Social Studies*. London: Routledge. 2010; *Religious Exoticism: The Logics of Bricolage in Contemporary Societies*. New York: Oxford University Press, 2014.

Véronique Altglas is a member of the ISSR since 1999. On request of its president, she created the ISSR Internet network of young researchers and animated the young researchers sessions during its conferences (2001-2004). She was the French representative on the ISSR Council between 2005 and 2013 and is currently the *Social Compass* editor for the ISSR conference papers (2013-2015).

INGER FURSETH

Inger Furseth, Dr. polit, is professor at Department of Sociology and Human Geography, University of Oslo and adjunct professor at KIFO Centre for Church Research, Norway. She got her doctorate degree in the social sciences from University of Oslo (2000). She has worked as research associate at KIFO Centre for Church Research, Oslo (1987-2013) (where she also was interim research director 2012-2013), adjunct professor in the sociology of religion at Norwegian School of Theology (2005-2012), and research associate at Center for Religion and Civic Studies, University of Southern California (2002-2013). She is also editor of the journal *Nordic Journal of Religion and Society* (since 2004).

Some of Furseth's books include *A Comparative* Study of Social and Religious Movements in Norway, 1790s-1905 (Edwin Mellen 2002) and From Quest for Truth to Being Oneself. Religious Change in Life Stories (Peter Lang 2006). An Introduction to the Sociology of Religion was published in 2006 (Ashgate), which she co-authored with Pål Repstad. This textbook is translated to three Nordic languages and Turkish, and in January 2015, it was selected by Ashgate as one of their books that have had the most impact. She co-edited The Changing Soul of Europe. Religions and Migrations in Northern and Southern Europe with Helena Vilaca, Enzo Pace, and Per Pettersson (Ashgate 2014). Furseth has also published numerous articles in Norwegian and international books and journals, including Social Compass. Her current writing includes articles from a project on "Religion in the lives of immigrant Muslim women in the Los Angeles area," and a book manuscript entitled "Contemporary sociologists on religion" with Pål Repstad. This book analyzes key social thinkers and their views on religion, and it will hopefully be finalized in 2015-17.

Furseth has been the director of a five year Nordic research project, "The role of religion in the public sphere. A comparative study of the

five Nordic countries" (NOREL), funded by the Nordic research councils, NOS-HS (2009-2014). The project focused on four topics: 1. Religion and state, 2. Religion and politics, 3. Religion and the media, and 4. Religion and civil society. The project included more than 20 researchers, including two PhD students. The edited book manuscript, Religion back in the public sphere? Religion and politics, media, state, and civil society in the Nordic Countries since the 1980s will be finalized the spring of 2015. A book from the Norwegian NOREL research will be published in Norwegian in April 2015 (Universitetsforlaget). Furseth's research interests cover a broad area within the sociology of religion: religion in the public sphere, religious diversity, gender issues, Muslim women, social and religious movements, and social theory. Furseth first attended a SISR/ISSR conference and presented a paper in Budapest in 1993. Since 2001, she has actively participated at every SISR/ISSR conference with papers, and arranged sessions at every conference since 2005.

IRENE BECCI

Irene Becci took her Bachelor and Master degrees in Social Sciences from the University of Lausanne, and made her PhD in Political and Social Sciences at the European University Institute, Florence in 2006. Since 2012, she is assistant professor at the Institute of Social Sciences of Religion, faculty of Theology and Religious Science, at the University of Lausanne with the focus on "Emerging religions and contemporary spirituality". Irene Becci has worked on the topic of religion in prisons in Germany and Italy during her doctoral and on religion for ex-prisoners in her postdoctoral studies, comparing Italy, Germany and Switzerland. She is currently enlarging her perspective to other state institutions dealing with religious diversity and spirituality, in particular on health institutions. Currently, she deals with contemporary expressions of "spirituality" in European urban contexts. Her most recent books are: "Topographies of faith" (2013, Leiden: Brill), coedited with Marian Burchardt and José Casanova and "Religious Diversity in European Prisons: Challenges and Implications for Rehabilitation" (2015, New York: Springer), co-edited with Olivier Roy.

Fatma Kocamemik Sündal received her Ph.D in Sociology from the Middle East Technical University of Ankara (2002). She conducted socioeconomic research in Eastern Mediterranean part of Turkey for KFW-Kreditanstalt für Wiederaufbau (1995) and taught introductory sociology courses at Bilkent University of Ankara (1996-1997), while she was still a doctoral student.

She was awarded a scholarship by Italian Ministry of Foreign Affairs (2001) and a post-doctoral research grant by TÜBA (Turkish Academy of Sciences) and hosted by Catholic University of Milan in 2002 and 2004. Since the end of 1997 she has been working at Anadolu University of Eskişehir.

She is currently an Assistant Professor at the Faculty of Humanities of Anadolu University of Eskişehir, teaching Sociology of Religion, Sociology of Everyday Life, Theory of Knowledge, and Qualitative Research Methods. She has been a member of ISA RC 22 between 2006 and 2014, and ISSR/SISR since 2006. Fatma (Kocamemik) Sündal is involved in both national and international research projects on religion and she has recently taken place within Editorial Board of a Book Publishing Programme on Theology and Religious Studies within Versita de Gruyter to represent Eastern Europe between 2011 and 2012.

LORI G. BEAMAN

Lori G. Beaman is the Canada Research Chair in the Contextualization of Religion in a Diverse Canada and Professor in the Department of Classics and Religious Studies at the University of Ottawa. Prior to completing her PhD in sociology in 1996, she was trained and worked as a lawyer, receiving her LL.B in 1987 and was in general practice until 1992. She has been a member of the ISSR since 2005 and the Society has been an important catalyst in her international programme of research. She is Project Director of a 7 year Social Sciences and Humanities Research Council of Canada funded Major Collaborative Research Initiative, entitled "Religious Diversity and Its Limits: Moving Beyond Tolerance and Accommodation," known as the Religion and Diversity Project (see www. religionanddiversity.ca). This international, comparative, multidisciplinary research project involves 37 team members at 24 universities in 5 countries, and explores the management of religious diversity along 4 axes, including religious identity, limits on religious freedom, sexuality and gender, and moving beyond tolerance and accommodation to a model of deep equality. Professor Beaman was awarded a Rockefeller funded residency in Bellagio, Italy in October, 2014 to complete a book manuscript on Deep Equality. She is also the incoming President (2016) for the Association for the Sociology of Religion and has a history of service to the ASR, as well as the Society for the Scientific Study of Religion (SSSR) as a member of council and programme chair. She sits on the advisory boards of IMPACT (Sweden) and the Centre for Religion, Conflict and the Public Domain (Netherlands), among others.

Professor Beaman is regularly invited to give plenary and keynote lectures, including keynote lectures at the 2014 Nordic Conference for Sociology of Religion, University of Copenhagen, Denmark; the 2014 Annual Conference of the Australian Association for the Study of Religion, Deakin University, Australia; and at the 2014 Nonreligion and Secularity Research Network, Pitzer College, U.S.A. MARY JO NEITZ

Mary Jo Neitz has been a member of the ISSR since 2008. She presented papers at the 2009 meetings in Santiago de Compostela and in 2013 in Turku. She has her Ph.D in Sociology from the University of Chicago, and is currently a Professor of Women's and Gender Studies at the University of Missouri, Columbia, Missouri. She has also served as president of the Association for the Sociology of Religion, Chair of the Sociology of Religion section of the American Sociological Association, and on the Council of the Society for the Scientific Study of Religion, as well as chair of the Women's Caucus of the Society for the Scientific Study of Religion. She has conducted ethnographies of Pentecostal Catholics, contemporary paganism and goddess spirituality, and congregations in six Missouri communities that were rural in 1950. She is interested in feminist methodologies, theory, gender and religion. She has published Sociology On Culture (Routledge, 2003) with John Hall and Marshall Battani; Culture: Sociological Perspectives (Prentice Hall, 1993) with John Hall (Chinese edition, 2002, Commercial Press of Beijing); Charisma and Community: A Study of Religious Commitment Within the Catholic Charismatic Renewal (Transaction Press, 1987); and Feminist Narratives and the Sociology of Religion, (AltaMira Press, 2001), edited with Nancy Nason-Clark. She currently working on a new book project, Gender in Small Town Churches: Organizational authority,

personal autonomy, and spiritual practices. In addition she has published numerous articles and chapters, of gender and religion, and feminist methodologies.

CENTRAL EUROPE

DINKA MARINOVIĆ JEROLIMOV

Dinka Marinović Jerolimov, PhD in sociology of religion (University of Zagreb) is a senior researcher (scientific advisor) at the Institute for Social Research in Zagreb where she has been working since 1985. Her main fields of interest are traditional church religiosity, minority religions, religious education and youth religiosity. She published two books about religious communities in Croatia, numerous book chapters, and articles in peer-reviewed journals. She has been attended ISSR/SISR conferences since 1995 and served as Vice-President of the Organizing committee of the 2005 ISSR/SISR conference in Zagreb, Croatia. Also, she was President of the Organizing committee of the 2001 ISORECEA (The International Study of Religion in Eastern and Central Europe Association) conference held in Zagreb, Croatia. Her interest in CEE region has been confirmed by long-standing participation as a member of the ISORECEA Governing Board and the Editorial board of its journal RASCEE (Religion and Society in Central and Eastern Europe). In 2014 she became President of ISORECEA. She was principal investigator for Croatia in the EUFP6 CA project REVACERN (Religion and Values in Central and Eastern Europe Research Network) and has been

principal investigator of the ISSP (International Social Survey Programme) for Croatia since 2005. She has been co-director of the Postgraduate course "Future of Religion" at the Inter-University Centre in Dubrovnik, Croatia since 2006.

MIA LÖVHEIM

Dr Mia Lövheim is since 2011 professor in Sociology of Religion at the Faculty of Theology, Uppsala University, Sweden. Her PhD in 2004 was entitled "Intersecting Identities: Young People, Religion, and Interaction on the Internet". Her research has since then focused on religious and gender identity among youth, particularly in discussion groups and blogs, and on religion in the lives of youth. More recently she has studied representations of religion in Swedish daily press, within the projects The role of religion in the public sphere: A comparative study of the five Nordic countries (NOREL) and The resurgence of religion?! A study of religion and modernity in Sweden with the daily press as case. She is currently involved in the comparative Scandinavian project Engaging with Conflicts in Mediatized Religious Environments.

Mia Lövheim plays a leading role within the Linneaus Center of Excellence and research program The Impact of Religion: Challenges to Society, Law and Democracy at Uppsala University. She has been the coordinator of the Nordic Network for media and Religion and is currently Vice-President of the International Society for Media, Religion and Culture (ISMRC). She is the editor of Modernities, Memory and Mutations: Grace Davie and the Study of Religion (with Abby Day, forthcoming May 2015, Ashgate), Media, Religion and Gender: Key Issues and New Challenges (Routledge 2013), Mediatization and Religion: Nordic Perspectives (with Stig Hjarvard, Nordicom 2012) and Religion som resurs? Existentiella frågor och värderingar i unga svenskars liv (Religion as a resource? Existential issues and values in the lives of Swedish youth, with Jonas Bromander, Artos 2012). Her work has also been published in several scientific journals Nordic Journal of Society and Religion, Culture and Religion, Nordicom Review, Information, Communication and Society and Feminist Media Studies, as well as in international edited volumes.

GIUSEPPE GIORDAN

Giuseppe Giordan, Ph.D. (2002) in Social Sciences, Pontifical University of St. Thomas (Rome), is Associate Professor of Sociology of Religion at the University of Padua (Italy). He is Co-Editor of the Annual Review of the Sociology of Religion (Brill), and elected member of the Executive Council of the Association for the Sociology of Religion.

He served as General Secretary of the International Society for the Sociology of Religion from 2009 to 2013 and as Secretary of the Italian Sociological Association – Section on the Sociology of Religion from 2007 to 2010.

He is author, co-author, editor or co-editor of fifteen books or journal special issues in the sociology of religion. His books include Identity and Pluralism. The Values of the Post-Modern Time. New York: Center for Migration Studies, 2004; Vocation and Social Context (ed.), Leiden: Brill, 2007; Conversion in the Age of Pluralism (ed.), Leiden: Brill, 2009; Youth and Religion, Annual Review of the Sociology of Religion (ed.), 1, Leiden: Brill, 2010; Religion, Spirituality and Everyday Practices (ed. with William H. Swatos, Jr.) New York: Springer, 2011; Prayer in Religion and Spirituality, Annual Review of the Sociology of Religion (ed. with Linda Woodhead), 4, Leiden: Brill, 2013; Religious Pluralism. Framing Religious Diversity in the Contemporary World (ed. with Enzo Pace), New York: Springer, 2014.

His sociological research focuses on the interaction between religion and spirituality, youth and religion, religious and cultural pluralism. His current projects are on the Christian Orthodox churches and Chinese immigrant religions in Italy.

Anna Halafoff

Dr. Anna Halafoff is a Lecturer in Sociology, and a member of the Alfred Deakin Research Institute for Citizenship and Globalisation, at Deakin University in Melbourne, Australia. She is also a Research Associate of the Religion and Diversity Project, led by Prof. Lori Beaman (University of Ottawa). Dr Halafoff is a sociologist of religion specialising in research on religion and diversity, interreligious relations, education about religions

and beliefs, countering violent extremism, and Buddhism in Australia. She has published one sole-authored book, one co-edited book, fourteen journal articles, thirteen book chapters and six conference papers. She has co-edited one Special Issue of Social Inclusion (Cognatio) and is currently co-editing another for the Journal of Intercultural Studies (Taylor & Francis) and for Studies in Interreligious Dialogue (Routledge). Dr Halafoff is also co-editor of a Book Series with Prof. Beaman and Assoc. Prof. Lene Kühle (Aarhus University) on Boundaries of Religious Freedom: Regulating Religion in Diverse Societies (Springer).

Dr. Halafoff is currently participating in a number of international research collaborations, including the Religion and Diversity Project's studies of religion and media and religion and education, a project on religion and education with the University of Warwick and Monash University, and the Critical Analysis of Religious Diversity Network led by Assoc. Prof. Kühle. She also regularly contributes to media discussion, and advises Australian government departments, faithbased community organisations and UN agencies on interreligious relations. Dr. Halafoff is a member of many learned societies including The Australian Sociological Association (TASA), the Australian Association of Religious Studies (AASR). She was Secretary of this Association from 2012-2013. Dr. Halafoff now co-edits the AASR's Journal for the Academic Study of Religion (Equinox), with Professor Douglas Ezzy (University of Tasmania). She has been the Convenor of the Australasian Association of Buddhist Studies' Victoria Chapter since 2012 and a member of the International Society for the Sociology of Religion (SISR/ISSR) since 2011.

Dr Halafoff first participated in the SISR/ISSR 2011 Conference in Aix-en-Provence, and cocoordinated a Thematic Session with Professor Gary Bouma on religion and education at the 2013 Conference in Turku. This TS resulted in a Special Issue of the Journal of Intercultural Studies mentioned above. Dr Halafoff will be cocoordinating a second religion and education TS at the 2015 Conference in Louvain-la-Neuve, with Prof. Beaman and Dr Elisabeth Arweck (University of Warwick). She will also assist Dr Bob Dixon and Prof. Bouma with organising the 2017 Conference in Melbourne.

For centuries the Catholic Church was able to impose her ethical rules in matters related to the intimate, that is, questions concerning life (from its beginning until its end) and the family, in the socalled Catholic countries in Western Europe. When the polity started to introduce legislation that was in opposition to the Catholic ethic, the ecclesiastical authorities and part of the population reacted. The media reported massive manifestations in France against same-sex marriages and in Spain against the de-penalization of abortion. In Italy the Episcopal Conference entered the political field in opposition to the relaxation of several restrictive legal rules concerning medically assisted procreation and exhorted the voters to abstain from voting so that the referendum did not obtain the necessary quorum. In Portugal, to the contrary, the Church made a "pact" with the prime minister so that the law on same-sex marriages did not include the possibility of adoption. And in Belgium the Episcopal Conference limited its actions to clearly expressing with religious, legal, and anthropological arguments its opposition to such laws, which all other Episcopal Conferences did also. In this book, the authors analyse the full spectrum of the issue, including the emergence of such laws; the political discussions; the standpoints defended in the media by professionals, ethicists, and politicians; the votes in the parliaments; the political interventions of the Episcopal Conferences; and the attitude of professionals. As a result the reader understands what was at stake and the differences in actions of the various Episcopal Conferences. The authors also analyse the pro and con evaluations among the civil population of such actions by the Church. Finally, in a comparative synthesis, they discuss the public positions taken by Pope Francis to evaluate if a change in Church policy might be possible in the near future.
